

## Related and Connected Issuer List

As part of the Wellington-Altus Group of Companies, Wellington-Altus Private Wealth Inc. ("WAPW") is a wholly owned subsidiary of Wellington-Altus Financial Inc. ("WAFI"). WAFI operates a diversified financial services business and, as part of its offering to its clients, WAPW may on occasion advise clients or trade in securities of an issuer who is related or connected to WAPW. Securities are considered "related" when WAPW and the issuer of the securities, through the ownership of, or direction over voting securities, have the following relationships:

- The issuer and WAPW are controlled by the same person, company or professional group<sup>1</sup>;
- The issuer controls WAPW; and/or
- WAPW and/or its professional group controls the issuer.

Securities are considered "connected" to WAPW where, due to indebtedness or other relationships with WAPW or its professional group, a reasonable prospective purchaser of the securities of the connected issuer might question the independence of WAPW from the issuer.

WAPW has policies and controls in place to ensure that any dealings in securities of related or connected issuers will comply with the investment objectives, restrictions, guidelines and other applicable provisions of your Client Account Agreements and Investment Policy Statement (as applicable).
